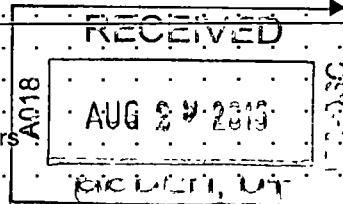

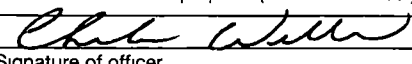

Part III. Statement of Program Service Accomplishment. Answer to what the organization's primary exempt purpose is: The purpose of the

Coast Range Association is to protect the Coast Range region's forest and related ecosystems from unwise use while fostering a new

vision of stewardship, diversity and long term sustainability. The purposes of the corporation are accomplished through public education,

research, and the advocacy of environmentally sound public policy toward the goal of building just and sustainable human communities

that provide for people and the natural world. The corporation's purpose and mission is accomplished through three specific programs

1. Conservation advocacy for terrestrial, freshwater, and marine biodiversity conservation, 2. Public lands management for native forest

and aquatic conservation values of clean water and native salmon, and 3. public interest research and advocacy for increased riparian

protections on private forestlands.

Answer to Part III Line 28: Conservation advocacy for terrestrial, freshwater, and marine biodiversity conservation and sustainable

community supported fisheries. CRA staff person Jim Calson supports coastal community groups in the implementation of three nearshore

nearshore marine reserves at Cape Falcon, Cascade Head and Otter Rock. Jim does this by advocating the best science about marine

reserves, conducting educational events and assisting the Friends of Cape Falcon Marine Reserve and the Friends of Cascade Head Marine

Reserve in their work of public education and aware of their local marine reserves and general ocean conditions.

Answer to Part III Line 29: 2. Public lands management for native forest and aquatic conservation values of clean water and native salmon.

During 2015 we continued to advocate and clarify the best available science relevant to freshwater ecosystems relevant to Western Oregon's

federal lands. We provided extensive information to the Bureau of Land Management on aquatic science related to their new Resource

Management Plans. We sought funding and secured a contract with Dr. Chris Frissell to produce a peer reviewed journal article based on

the 2014 aquatic science synthesis paper produced by the independent aquatic science panel we sponsored in 2014. In addition, we provided

extensive comments and aquatic science question to the USDA Forest Service research group working on a science synthesis for

upcoming National Forest planning to replace the Northwest Forest Plan.

Answer to Part III Line 30: 3. Public interest research and advocacy for increased riparian protections on private forestlands. During 2015

we supported the work of Mary Scurlock to present best available aquatic science and clear legal interpretations of federal mandates to the

Oregon Board of Forestry. The Board is in a formal process to consider adequate riparian buffers during timber harvest on private lands.

Line 28 and Line 29 programs benefit all the people of the United States through the conservation of freshwater, marine and terrestrial

biodiversity. Line 30 program benefits the people of Oregon.
