 Civic Engagement Work On May 21, 2015, Oregon became the third state to pass a ban on conversion therapy when Governor Kate Brown signed the Youth Mental Health Protection Act, which prohibits conversion therapy for youth under the age of 18 by licensed mental health providers The Act was Basic Rights Oregon's top legislative priority in 2015, and we proactively secured endorsements from more than 30 organizations including all major health care and social service professional associations in the state, racial justice and student leadership groups in shepherding its passage
