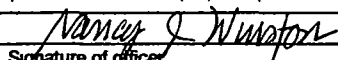
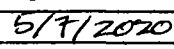

PMBA is a community-based organization whose membership comprises both backyard and commercial beekeepers. The club is managed
by volunteer members elected to various positions by the membership. PMBA members meet each month to learn best practices through
presentations by experts, conversations and club-sponsored events and classes. In addition, members benefit from special pricing on nucs
(nucleon hives), sugar, hive maintenance and equipment. All of this is accomplished through the efforts of volunteer members.

PMBA members reach out to the community regarding various aspects of beekeeping and stewardship of pollinators in our area. Members
volunteer throughout the community - at county and state fairs, gardening shows, schools, and other local community meetings.

PMBA members also teach an annual class in cooperation with the local community college.

PMBA efforts/programs support of the OSU Honeybee lab and other vital research efforts are supported by member dues, Bee Day activities
and program services.

Bee Day also include two field sessions, presented by member volunteers, for attendees to gain hands-on experience with honey bees in open hives: finding eggs, brood, queen, for example. Additionally PMBA hold a raffle of equipment and supplies donated by beekeeping suppliers and other local businesses (e.g. bee-friendly plant material donated by a local nursery).
