



SAFETY & SENTENCING The Safety & Sentencing Program supports approaches to public safety that are both fiscally responsible and reduce society's over-reliance on incarceration as a response to crime. Informing policy makers and the general public about the "Justice Reinvestment" model, Family Sentencing Alternatives, and Law Enforcement Assisted Diversion are the focus areas of our work to help build safe and healthy communities. By reducing over-reliance on the use of prison and redirecting public resources toward local provision of evidence-based crime prevention programs, we believe that society can reduce crime and ensure a system of justice in which both the crime victims and people who have been held accountable for crimes are able to rebuild their lives

CRIME SURVIVOR PROGRAM The Crime Survivors Program supports the mobilization of crime survivors calling for a more effective public safety system— achieved not through longer sentences for people convicted of crimes, but through public safety reforms that prevent crime at the outset, that better meet victims' needs through effective services & appropriately funded programs, & that provide long-term solutions to the underlying causes of crime. PSJ is working with survivors of domestic & sexual violence & victim advocates to support Justice Reinvestment to increase funding for Oregon's domestic & sexual violence service programs. We collaborate closely with crime survivors & victim advocates who oppose Oregon's mandatory minimum sentencing structure, because it creates a barrier to victims accessing the justice system & wastes resources that should be spent on essential programs. PSJ is helping to lead national conversations between victim advocates & criminal justice reformers, who are together creating a new paradigm on public safety policies that better meet people's needs

YOUTH JUSTICE PROGRAM The Youth Justice Program supports responses to crime that appropriately hold young people accountable based on their level of development and special needs. In particular, we seek to reverse policies in Oregon that cause older children to be prosecuted as if they were adults and that impose extreme mandatory minimum sentences. National research shows that public safety is best served when youth who have committed crimes are dealt with within the juvenile justice system rather than the adult system. During the past year, PSJ worked to ensure that youth charged as adults are not held together with adult prisoners and supported efforts to review the progress of young people serving long sentences for opportunities to safely and productively accelerate their reintegration into society
