 COMMUNITY IMPACT - SINCE 2011, SVPP HAS FOCUSED OUR MISSION ON ENSURING THAT ALL CHILDREN ENTERING KINDERGARTEN ARE PREPARED FOR LEARNING AND LIFE SUCCESS. THE KINDERGARTEN READINESS CRISIS HAS EMERGED AS AN URGENT PRIORITY IN OREGON. IN MULTNOMAH COUNTY ALONE, APPROXIMATELY 30,000 CHILDREN ARE FACING THE RISK OF FAILURE BY KINDERGARTEN. COMPOUNDING THIS FAILURE, RESEARCH SHOWS THAT A CHILD WHO FALLS BEHIND BY THE FIRST GRADE HAS ONLY A 13% CHANCE OF EVER CATCHING UP TO HIS OR HER FUTURE GRADE LEVEL.
