| PROTECTING PUBLIC HEALTH-ACTING ON BEHALF OF ITS MORE THAN 41,000 MEMBERS, WHO BELIEVE THAT PROTECTING PUBLIC HEALTH IS A BATTLE WORTH FIGHTING, THE CALIFORNIA MEDICAL ASSOCIATION (CMA) JOINED THE AMERICAN HEART ASSOCIATION, AMERICAN LUNG ASSOCIATION IN CALIFORNIA, AMERICAN CANCER SOCIETY CANCER ACTION NETWORK, SEIU CALIFORNIA AND DOZENS OF OTHER HEALTH CARE ADVOCATES ACROSS THE STATE AS A MEMBER OF THE SAVE LIVES CALIFORNIA COALITION. | PROTECTING THE PRACTICE OF MEDICINE-THROUGHOUT 2015, CMA DEDICATED NUMEROUS RESOURCES TO THE SUCCESSFUL DEFEAT OF SEVERAL SCOPE-OF-PRACTICE EXPANSION ATTEMPTS BEFORE THE STATE LEGISLATURE. EACH OF THE BILLS CLAIMED TO BE A SOLUTION TO CALIFORNIA'S ACCESS TO CARE CRISIS, BUT, IN REALITY, POSED A VERY REAL DANGER TO PATIENTS. CMA STRONGLY BELIEVES THAT SIMPLY EXPANDING THE SCOPE OF PRACTICE OF ALLIED HEALTH PRACTITIONERS TO GIVE THEM INDEPENDENT AND/OR EXPANDED PRACTICE WILL DO NOTHING TO IMPROVE ACCESS TO CARE OR QUALITY OF CARE IN OUR STATE. ALLOWING PRACTITIONERS TO PERFORM PROCEDURES THEY SIMPLY AREN'T TRAINED TO DO CAN ONLY LEAD TO UNPREDICTABLE OUTCOMES, HIGHER COSTS AND GREATER FRAGMENTATION OF CARE. THE MEASURES CMA DEFEATED INCLUDE THESE DANGEROUS BILLS: SB 323 WOULD HAVE ALLOWED NURSE PRACTITIONERS TO PRACTICE INDEPENDENTLY AND PRESCRIBE DRUGS WITHOUT PHYSICIAN OVERSIGHT; SB 622 WOULD HAVE ALLOWED OPTOMETRISTS TO PERFORM AN ARRAY OF SUPPLEMENTARY PROCEDURES WITH LITTLE ADDITIONAL TRAINING. THAT MEASURE WOULD HAVE PERMITTED OPTOMETRISTS TO PERFORM SCALPEL SURGERIES, LASER SURGERIES AND INTRAOCULAR INJECTIONS; SB 538 WOULD HAVE ALLOWED NATUROPATHS TO PERFORM, REVIEW AND INTERPRET THE RESULTS OF DIAGNOSTIC PROCEDURES, INCLUDING BUT NOT LIMITED TO VENIPUNCTURE, ELECTROCARDIOGRAMS AND DIAGNOSTIC IMAGING. |         |              |                        |             |

| MEDICARE PAYMENT REFORM-CMA WAS INTEGRAL IN THE 2015 PASSAGE OF FEDERAL LEGISLATION TO REFORM THE BADLY BROKEN MEDICARE PHYSICIAN PAYMENT SYSTEM. THIS LEGISLATION IS WORTH BILLIONS OF DOLLARS TO PHYSICIANS NATIONWIDE OVER THE COMING DECADE.
