Once completed, executive management reviews the form for accuracy and reasonableness. The completed form is then presented to the board of directors for their review prior to filing. SAFE also has a formal process that provides employees of SAFE a means of reporting any complaint or inappropriate activities directly to the supervisory committee or directly to our regulator, the California Department of Financial Institutions.
