Credit Counseling, Financial Fitness and Debt Management Services BALANCE provides comprehensive one-on-one counseling to individuals and families on a wide range of money management and credit related issues involving budgeting, debt management, retirement planning, improving credit, and other credit related matters About 15 percent of these counseling sessions result in the consumer choosing to participate in an individual customized debt management plan Participants make one monthly payment, in an amount negotiated with the creditors, to BALANCE, which is then distributed to the creditors In 2015, BALANCE helped consumers pay back over \$30 million dollars in debt, resulting in over 4,400 families becoming debt free In 2015, CCCS of SF, DBA BALANCE partnered with local government, businesses, and other non-profits to provide financial coaching, credit counseling, housing education, in person financial education, and online education BALANCES toll-free hotline provided 185,000 consumers with immediate answers to questions about credit reports, credit scoring, wage gamishments, student loans, identity theft, and other credit related matters Creating a path to financial empowerment via the Financial Fitness program helped many families avoid bankruptcy, foreclosure, eviction, and the negative impact of credit issues

Credit and Housing Education and Counseling BALANCE delivers comprehensive financial wellness programs In 2015, BALANCE helped over 17,200 families take charge of their personal finances Free workshops helped to teach sound personal financial skills, money management, the wise use of credit, and the essential issues of home buying Over 270 workshops and 34 webinars were delivered with more than 5,100 individuals in attendance To ensure education was available on demand, online education modules were offered allowing consumers the convenience of accessing financial and credit education in a digital format from a computer or mobile device Over 73,000 consumers completed one of our online modules in 2015 To help those facing foreclosure, over 8,200 sessions were conducted for foreclosure alternatives and another 7,100 sessions were conducted for foreclosure prevention

community members annually Their service continuum offers emergency residential shelter and community-based services to women, teens and their children while providing advocacy, counseling, family-based services and referrals Their Mission Street office houses their 24 hour crisis phone lines, Drop-In Counseling Center, Teen Program, and Community Education and Outreach Program, while offsite they run the Emergency Shelter, Domestic Violence Response Team, Safe Havens Project, Mary Elizabeth Inn Case Management Program, and Safe Housing Project BALANCE has conducted a number of money management workshops at La Casa De Las Madres emergency shelter, The Mary Elizabeth Inn, over the years on consumer related issues such as Basics of Money Management and Credit, Downsizing Your Debt, Holiday Survival Skills, Psychology of Spending, Raising Money Smart Kids, Savings 101, Steps to Financial Success, Understanding Taxes, and Understanding Your Credit Report In addition, we work identity, and identity theft All foster youth and non-minor dependents ages 14-21 receive a copy of their Experian, Equifax, and TransUnion credit reports annually from their Human Services Agency Case Manager BALANCE is then available to help review and interpret their credit reports as well as instructions on how to dispute inaccuracies and address identity theft We also have developed an educational program for Case Managers on how to access credit reports and better understand the credit report process SAN FRANCISCO SMART MONEY NETWORKIn early 2009, BALANCE was invited to participate in the San Francisco Smart Money Network (SMN) sponsored by the San Francisco Treasurers Office and the Charles Schwab Foundation This collaboration brings together the leading community organizations counseling to help families through the current housing crisis, and pre-purchase education for first-time home-buyers for those families who realize that the best time to buy a home may be now when interest rates are low, and housing prices have dropped, and debt management plans for families overwhelmed with debt We offer an on-going series of free workshops to the individuals and families of the communities we serve Our workshop series is directed to those who are interested in financial education as well as those who want to become first-time home-buyers BALANCE participates with other community-based organizations and gladly accepts referrals into our workshop series Our workshops are open to the public To publicize these free workshops we do the following 1 Post our Workshop Independence We also offered 19 on-line personal finance education modules through our website to nearly 73,000 consumers across the United States Our vision of being The most trusted source for financial advice in the nation, inspiring and empowering people from all walks of life to achieve their financial dreams remained at the core of all of our educational offerings in 2015COMMUNITY OUTREACH BALANCE believes in providing community outreach to the diverse population in the Bay Area We stay connected to our local community through local English and foreign language television stations Our bilingual counselors can provide services in Spanish, Chinese, Vietnamese, and Tagalog For other languages, we utilize AT&Ts Language Line We participate in local TV and radio interviews, as well as call-in shows to increase awareness of our services AGENCY PUBLICATIONSBALANCE believes everyone could learn more about how to manage income, handle a budget, read a credit report, buy a house, and achieve economic goals We have a section on our website that provides information for people with questions in the following areas Money ManagementCredit and DebtStudent LoansCredit Reports and ScoresHousing, Planning for the FutureIdentity Theft and FraudLegal IssuesTaxesTeens and MoneySenior IssuesA special section of our website has been dedicated to educational resources such as articles, booklets, toolkits, videos, podcasts, newsletters, and calculators This can all be sourced for free at www.balancepro.org/resources INTERNAL TRAINING & CONTINUING EDUCATION BALANCE strongly believes in providing education to our clients and our local communities in money management information to help people achieve their financial goals In order for us to provide quality information to the people we serve, we provide extensive training to all of our counselors Newly hired counselors participate in a month-long training program that includes training sessions on everything from counseling techniques to updated resources and new referrals All of our counselors are required to successfully complete a national certification program developed by Purdue University specifically for members of the National Foundation for Credit Counseling (NFCC) within the first six months of employment However, we have consistently been able to certify our counselors within 90 days of employment This certification process covers such topics as consumer protection, spending plans and budgeting, creditor and legal policies and practices, credit and debt management, and counseling principles and techniques Counselors must also maintain their certification by earning additional Professional Development Units (PDUs) during each two-year period Counselors are encouraged to continue their NFCC certification by learning additional topics in housing counseling, outreach programs, insurance counseling, savings and investment counseling, retirement planning counseling, and effective shopping decisions counseling Counselors are encouraged to share new knowledge of published articles in newspapers and trade publications on topics related to financial counseling, consumerism, education on topics related to NFCC and its affiliated agencies to the agency SAN FRANCISCO SUICIDE PREVENTIONOccasionally, we determine that a specific need exists for agency personnel Such was the case with San Francisco Suicide Prevention San Francisco Suicide Prevention (SFSP) is the oldest volunteer crisis line in the United States It was founded in 1963 with the initial focus of providing telephone intervention to people experiencing suicidal crisis Over the years, the focus of the agency has gradually shifted from strictly suicide prevention to more general counseling services Services are provided 24 hours a day by over 150 trained volunteers with the supervision of a small multidisciplinary staff SFSP is divided into four program areas which operate eight hotlines In mid-2005 our agency began to experience an increase in mortgage default counseling We call this service crisis counseling because the individual or family is under terrific stress when placed in foreclosure As we began to hire additional employees to meet this need initially we failed to recognize that most counselors have never been trained around the issue of suicide prevention In one particular case, our counselor was conducting a telephonic mortgage foreclosure prevention session with a father in a household of four The father was extremely despondent and felt he was a failure for not being able to provide adequately for his family and the thought of losing the family home was unbearable While speaking to our counselor, this client indicated he had a gun in his hand and was just going to end it all Our counselor heard the sound of the gun being cocked Fortunately, the counselor remained calm and talked the client through his terrible stress without incident This incident made us realize that we needed to have professionals from our community partner, San Francisco Suicide Prevention, train our staff on how to handle these situations and what to recognize and do in these emergencies when they occur Their staff comes to our office on a regular basis to explain their services, and to train our counselors on what they should do to assist their clients who show signs of possible suicidal tendencies during their counseling sessions The SFSP trainings have been extremely valuable to our Counselors since many consumers who are in a financial crisis are also in an emotional crisis COMMUNITY COLLABORATIONS FOR FINANCIAL EDUCATIONBALANCE is very active with our local community based organizations in providing financial literacy education We regularly participate in educational community events such as the San Francisco Home Expo, which provides consumers access to affordable housing and education on how to become a homeowner, as well as Financial Planning Day, which we participate in throughout the state of California HOMEOWNERSHIPSF HomeownershipSF serves as a centralized resource for affordable homeownership opportunities in San Francisco HomeownershipSF makes the home buying process easier for first-time home-buyers by combining information on works
