The National Judicial College (NJC) receives funding through the U.S. Department of Justice (its cognizant agency); U.S. Department of Transportation; and the State Justice Institute in support of training and research projects addressing the administration of justice and the rule of law. During 2015, NJC designed programming, publications, and websites; provided technical assistance to the justice community and conducted educational programs including: Essential Skills for Lay Advocates in Tribal Court; Writing and Amending Codes; Domestic Relations Codes; Practical Approaches to Family Issues in Tribal Court; NHTSA In-State programs in Indiana, Illinois & Wisconsin; Walking on Common Ground (Eastern Tribes). Additionally, the Departments of Justice and Transportation help support attendance at tuition-based courses by supporting participant travel costs when state and local funding is unavailable.

The College conducts courses for judges, court personnel, mediators, and others who perform quasi-judicial and administrative functions in the justice community. Course participants come from all 50 states, U.S. territories, and numerous foreign countries. The range of programs is extensive, including new judge training, mediation, administrative law programs, family law and tribal court programs. Courses deal with both civil and criminal law and are held on-site at the College on the campus of the University of Nevada-Reno, at locations around the country and via the web. Through its programming NJC works to improve judicial knowledge, court administrative skills, productivity and to inspire judges to achieve judicial excellence. Among the course offered in 2015 were: Leadership for Judges; Drugs in America Today; Managing Challenging Family Law; Handling Capital Cases; Ethics, Fairness and Security in the Courtroom; Criminal Evidence; Complex Commercial Litigation. The College's tuition-based courses are just one of the ways NJC supports its mission "to provide leadership in achieving justice through quality judicial education."

In addition to providing tuition-based education courses, The National Judicial College provides custom designed judicial education programs to meet the individual needs of the court systems, associations, state judicial education bodies and administrative law agencies throughout the country. Some of the programs that NJC created and presented in 2015 were: High Performance Courts - DC OAH; Advanced Topics in Administrative Law for NSCB; Collaborative Decision Making - KS Judicial Center; Diversity Education - DC OAH; Delinquency & Unruly Webcast: Ohio Supreme Court. The College also conducted program faculty development and distance learning workshops for individual state administrative offices of the court and training centers to assist them in providing quality education programs.
