The Hospital de la Familia Foundation is a 501(c)3 organization based in San Francisco, California that supports a 72-bed hospital, as well as educational and wellness programs in the rural town of Nuevo Progreso, in the Department of San Marcos, Guatemala, serving approximately 16,500 low-income patients per year HDLFF coordinates missions of volunteer medical teams specializing in general surgery, plastic surgery, OB/GYN, ear, nose and throat, ophthalmology, optometry, dentistry, pediatrics, and audiology In 2015, the total number of patients seen in clinics by Guatemalan and U S doctors totaled 16,493 U S medical teams saw 4601 of those patients and performed 1241 surgeries In addition, the nutrition center for malnourished infants and toddlers treated 48 children in 2015 The grade school for girls and boys which enrolled 156 children (grades 1-6) had 31 sixth graders graduate (18 girls and 13 boys) The nursing school which enrolled 36 students had 23 graduates who received their diplomas as medical assistants The sewing school which enrolled 24 women and girls had 7 graduates
