Valuescience—offered "Valuescience: Shedding Illusion to Live Better" at Stanford University spring and autumn quarters; presented valuescience to more than 1,000 individuals at Magic and in business, school, and other community settings.
Residential Education: 42 interns and affiliates from throughout North America, and from Asia and Europe participated for one to several months; 20 were accepted for longer stays; Resident Fellows provided interns and affiliates more than 1,000 hours of guidance in living in valuescience-based service learning community; hosted Barry Bolton to screen his documentary film about ethnic minority groups in China; hosted 8 "Soup and Sits"—silent meditations followed by a light meal; hosted Esther Cole, Stanford Conservation Program Assistant Manager, to present her Dish hill plant community mapping project; presented philosophical underpinnings of Magic and unique building features of "A Better Home."

Cooperation & Individual Well-Being—Liveable City: hosted 36th annual Evergreen Park Neighborhood Association picnic; hosted the annual Evergreen Park Neighborhood Association block party; hosted a neighborhood potluck; continued a vendor donation program through which we collected and processed thirty tons of food surplus from the California Avenue Farmers' Market for use in programs of Magic and of Community Services Agency and 1,000 Grains, local charities that serve low-income clients.
Planning for Living: delivered 1 two-session seminar with weekly follow-up for 3 months to 15 Magic service-learning community residents. **Movement Magic**: provided 100 hours of swimming, running, cycling, and other somatic awareness instruction to residents and to 20 clients from beyond the Magic residential service-learning community; hosted Louis Jackson to give a four-day core immersion yoga workshop; from March through year-end taught weekly yoga classes to an average of 6 clients per class.
Creating Loving Community: provided 100 hours of consultation to persons inquiring about living in intentional community; hosted 50 people from the Magic circle for Thanksgiving dinner and celebration. **A Better Home**: served on a city of Palo Alto and Passive House California sponsored "Building Net Zero" conference panel and gave 75 conference attendees a building tour; presented A Better Home at Stanford as part of the American Society of Civil Engineers lecture series.

Environmental Stewardship—Planting for the Second Hundred Years: Engaged 650 volunteers diverse in age and background; partnered with a half-dozen schools and middle schools, Stanford alumni, Stanford service dorm, Stanford Tzu Chi, Stanford Alpha Phi Omega, Stanford Wrestling, SAP Corporation, Google, and other groups whose affiliates contributed more than 1,625 hours of volunteer service to nurture 600 seedling oaks and other native trees in Magic's on-site nursery, transplant 50 young oaks and 300 other California native trees, shrubs, and vines into publicly accessible open space, monitor and nurture 2,000, and hand-water 400 previously planted oaks and other California natives growing in open space used by 600,000 visitors annually.

While receiving benefits, Bayer and Schrom were delivering Magic services 7 days per week at all hours of the day. This responsibility included supervision of Magic resident interns and operating personnel.

Part IX, Lines 11-24, Column C: We estimate overhead expenses to be approximately 10% of the operating budget.

Part IX, Lines 11-24, Column D: Magic does no fundraising apart from that which is incidental to delivery of program services.

Part IX, Line 24e: The entry in this line includes a miscellaneous expense of \$7,210. After repeated attempts to collect the receivable, Magic is writing it off over a 2-year period. While Magic hopes to recover some of the asset, we realize we will likely recover none of it.
