Ability Tools - is dedicated to expanding the availability of tools, resources and technology that increases independence, improves personal productivity and enhances the quality of life of Californians with disabilities. We support Device Lending Libraries, Reuse Centers and Independent Living Centers throughout the state. We provide funding, training, and technical assistance to a network of over 1600 organizations and individuals. We developed the Freedom Tech Alternative Finance Program to provide low interest loans to people with disabilities and their families who are seeking loans for Assistive Technologies home or vehicle modifications.

Disability Organizing Network is a focused on organizing for accessible communities. We support statewide and regional organizing campaigns that are driven by local communities. In 2015 we achieved systems change impacting the access of California's online voter registration system, and the accessibility of the Bay Area Rapid Transit's new Fleet of the Future.

Digital Access Project is focused on bridging the Disability Divide by offering assistance to people with disabilities to access available low-cost internet options. In 2015 we connected 1370 individuals to low-cost internet services.
