ZYZZYVA successfully executed its primary project of publishing the tri-quarterly print journal In keeping with our mission since inception, our goal was to continue publishing the journal and to continue our support for writers and artists through the journal and through events To that end, we published three exemplary issues of the journal in 2015, featuring new works by 56 writers and substantial portfolios by 4 visual artists, in beautifully produced and carefully edited volumes which were distributed to bookstores and newsstands nationwide We hosted or participated in 19 free events to bring publicity and attention to our authors, and to contribute to a vibrant public life around the literary arts We produced 5 author interview videos, available for free to the public via our website We continued to offer emerging talents a valuable, nationally distributed platform (featuring fiction by 26 emerging writers in the journal over the course of the year) while also offering substantial support (through publicity, in print and online, through events, and through sustaining our increased author payments) for all our authors, emerging and established alike

Part I Additional Information	<p>ZYZZYVA History and Mission ZYZZYVA was founded in 1985 as a not for profit arts organization whose main project is publication of a journal of contemporary art and literature. Over the past 31 years, ZYZZYVA has grown into a critically acclaimed cultural platform of national significance. We bring new work from the finest contemporary writers and artists to a national audience through a print journal, published three times a year, curate a vibrant year-round schedule of free events, and maintain our website, zyzzzyva.org, which offers original writing, video podcasts, interviews, and criticism. Beneficiaries ZYZZYVA's mission is to support contemporary artists and writers through publication of a print journal, and to foster a vibrant public life around the contemporary arts through an events series that is open to the public, free of charge. Beneficiaries of our programs therefore include writers, artists, and our audience of readers and event attendees. ZYZZYVA has published 106 issues, bringing national attention to emerging and established writers, poets, and visual artists. The journal is available in 119 bookstores nationwide, as well as 116 libraries. Many of contemporary literatures most lauded voices have launched their careers within the pages of ZYZZYVA, making it a reputable and pedigreed resource for new writers hoping to break through. Po Bronson, Chitra Divakaruni, Haruki Murakami, Jim Gavin and F X Toole all first appeared in the journal, ZYZZYVA was also an early publisher of Sherman Alexie, Molly Giles, Kay Ryan, Adrienne Rich, Raymond Carver and many others. Work appearing in the journal has consistently been reprinted in literature's most notable anthologies and garnered dozens of awards and prizes. In 2015, our issues once again drew national recognition and praise. One of our emerging writers won a Pushcart Prize for her work. Two additional stories were selected for inclusion in the 2016 Best American Short Stories, while yet another story was selected for the O Henry Prize Stories 2016. In addition, an essay was selected for inclusion in the 2016 Best American Nonrequired Reading anthology and in the 2016 California Prose Directory. ZYZZYVA's efforts to promote authors' work often pays off with other dividends. Recently we were thrilled when Vanessa Hua, a San Francisco writer we published in 2011 and again in 2013, landed a two-book publishing deal with Ballantine, both novels were developed from the works first published in ZYZZYVA. Writers and artists highlighted in our journal have also gone on to receive attention for their creative excellence from National Endowment for the Arts, the Fulbright Scholar Program, the Rona Jaffe Award, and Guggenheim Fellowships. Our robust events series reaches wide audiences every year, in 2015 our events were attended by an estimated total of 980 people. ZYZZYVA therefore serves an important role in supporting contemporary authors and artists, and in creating community around the arts. Attraction of Public Support ZYZZYVA has a dedicated and engaged donor and subscriber base, and has sought and received support from a variety of public sources. However, the sources of financial support for a literary organization are always hard to come by, especially given the limited resources of our small staff. Over the past five years, we have reinvigorated our grant-seeking program, our donor cultivation and interaction, and our fundraising campaigns (events, online, and mail campaigns). As a result, we have seen our individual donations grow from \$14,000 in 2011, to more than \$40,000 in 2013 a trend which we intend to continue and build upon. We currently have grant applications pending with several government and private funders. Our grant-seeking in 2014 resulted in a generous gift from the National Endowment for the Arts (NEA) for our 2015 year, which increased our public support percentage. The NEA continued that support with another grant for our 2016 year as well, and we also received funding from several other private foundations. The public support percentage for 2015 and 2014 were 21.39% and 22.68% respectively, both of which are well in excess of the minimum 10% requirement, and we fully expect the percentage to increase going forward. Public Participation in Programs ZYZZYVA does more to engage a public audience than any other literary magazine of its size. On our own and in partnership with a diverse array of other arts organizations, we host or participate in up to two dozen events each year all of which (with rare exception) are free and open to the public. We reach a broad public audience through these events, most of which are attended at capacity, our combined estimated attendance for our 2015 programs was about 980 people. We also engage with the public through our vibrant, frequently updated website. There we offer original content (separate from what we publish in the journal) such as essays, video interviews with authors, book and theater reviews, and highlights from our archives, all of which is available to the public, for free. Our annual online audience is about 73,000. Recent Challenges and Growth Like many literary print journals in the 21st century, ZYZZYVA has faced its share of financial hurdles. The post-recession period was especially challenging, with our organization accruing operating deficits over multiple years. Upon assuming stewardship of ZYZZYVA in 2011, Editor Laura Cogan took several steps to strengthen the journal's long-term viability and financial health, these steps were taken swiftly, but, as can be expected, their benefits take time to fully develop. To help the organization get back on its feet, several large donations were solicited in attempts to keep the organization solvent, which was successful - but such donations ultimately hurt the public support percentage necessary for public charity status. In 2014 we faced another setback when we lost our office after our rent was doubled. Although the rent on our new space is less expensive than it would have been to keep our old space, as is consistent with the upward trend in San Francisco's rental market, it is still far more than our rent in previous years. Higher earned income from sub-rentals and increased sales and donations were not enough to entirely offset this unexpected increase to our administrative expenses, leading ZYZZYVA to end 2014 with a small operating deficit. ZYZZYVA has taken vigorous steps to increase our financial health every year. We created and initiated our first year-end fundraising campaign in 2013, which led to a 20% increase in revenue that year and was even more financially successful in 2014. ZYZZYVA also launched, for the first time ever, an annual fundraiser event in 2014, which has helped raise more money for the organization each year, and helped cultivate donor relationships. To help build these new programs, ZYZZYVA hired a development consultant to help develop our fundraising infrastructure an investment necessary to give us the tools to survive and grow as an organization. We are moving to end 2016 and future years in a healthy financial position by keeping our operating costs lean and continuing to build on contributed income with the strategies we developed in 2014 and fine-tuned in 2015. These strategies include continuing our work to increase our individual donor base, and aggressively pursuing grant opportunities including government and private foundations. Our Board of Directors, though small, is a dedicated group of accomplished professionals from all backgrounds who see the value of this vibrant and productive arts organization, and support us in their various communities. Amid all these efforts, ZYZZYVA remains steadfast in our commitment to supporting our authors by paying them well, and to playing a vibrant role in the Bay Area arts community. For these reasons, ZYZZYVA should continue to qualify as a publicly supported charity.</p>
