Our films and resources have been presented to and promoted by numerous partners and organizations: the FBI, International Association of Chiefs of Police, the National Sheriffs' Association, the National Criminal Justice Association, International Association of Official Human Rights Agencies, the U.S. Attorney's Office, the Association of Prosecuting Attorneys, the National Council of Jewish Women, the U.S. Capitol, Parliament of the World's Religions, and the American Society of Criminology, to name a few, among many schools and universities, law enforcement organizations, and community and religious groups. As of December 2015, more than 3,515 DVDs and more than 700 guides have been distributed.
