In addition, to help achieve a more diverse state bar, the California Bar Foundation provides scholarships to law students of diverse backgrounds throughout the state. In 2015, the California Bar Foundation invested more than \$225,000 in Diversity Scholarships for 30 students and \$54,375 in Public Interest Bar Exam Scholarships for 15 students.
