Education of Clergy - Through the travels of its pastoral team to visit parishes and present seminars, through media broadcasts and publications and through regular one-on-one consultation given to priests around the world, the Priests for Life, Inc. pastoral team continued to educate and equip priests, deacons and seminarians to effectively proclaim the pro-life message and compassionately counsel those tempted to have abortions and bring healing and forgiveness to those who have already had abortions. In particular, the liturgical resources and homily hints, in English and Spanish, continue to be provided in print, on You Tube channels, and through a smartphone app. These liturgical resources cover every Sunday of the three-year liturgical cycle. In 2015 Fr. Pavone also wrote two books to be published next year: The first was "Proclaiming the Message of Life" (Franciscan Media) in which he offers a comprehensive guide for priests to present a life-affirming message from the Sunday Lectionary readings for the entire three-year cycle. The second was "Abolishing Abortion: How You Can Play a Part in Ending the Greatest Evil of Our Day" (Thomas Nelson), in which he explores biblical, moral, historical, and legal reasons that Christians belong in the public square, and challenges both churches and individual Christians to full engagement with our secular society.

Media - In 2015 Priests for Life, Inc. produced for EWTN a new season of "Defending Life", the longest running and farthest reaching TV program on abortion. We also produced a new season of "The Catholic View for Women" as well as a taping of our Spanish series, "Defendiendo la Vida". Our internet program, "Pro-life Straight Talk", continued and we expanded our internet broadcasting to include other new programs as well as weekly pro-life homilies. Throughout the year, Priests For Life, Inc. had a presence in the following Media outlets: Fox News, EWTN, Christian Broadcasting Network, the Washington Times, Cyber News Service, LifeSite News, Newsbusters, American Thinker, Catholic News Service, Newsmax, Charisma News, LiveAction News, LifeNews, the Gospel Herald, MedPage Today, the National Catholic Register, the Blaze, Western Journalism Report, The Troy Daily News, WHIO-TV, Dayton Daily News, USA Today, The Philadelphia Inquirer, Daily Caller, CNS News, Pewsitter, The Washington Examiner, The Christian Review, Wanderer Press and Associated Press. The topics ranged from press conferences regarding the Shockwaves of Abortion initiative, to the success of the abortion-pill reversal process and our own Supreme Court case against the HHS Mandate. We were also able to launch a new series of Op-Ed columns for the Breitbart Network, and take part in media events on Terri Schiavo's Anniversary, late term abortions, the United Nations, Nancy Pelosi's Catholicism, Pope Francis in the US and abortion laws.

International Outreach - In 2015 Priests for Life, Inc. hosted an International Pro-Life Symposium attended by over 1,500 people from around the world in conjunction with the Pontifical Council for the Family's World Meeting of Families. In addition, Priests For Life, Inc. participated in several strategic Family and Life meetings at the Vatican, including its Academy for Life annual conference and Council for the Family in Church & Contemporary World meeting. Priests for Life, Inc. was involved in international legal research, writing and publication on Pro Life themes. Research, writing and publication regarding inter-religious pro-life work collaboration and canonical research and consultation. Priests For Life, Inc. continued its participation at the United Nations as a Non-Governmental Organization in special consultative status with the Economic and Social Council by submitting statements and participating in key conferences such as the Commission of the Status of Women, Commission on Social Development and the Commission on Population and Development.

Form 990 Part III Question 4d-Other program services

1-Closing of abortion mills - We continued to work with Operation Rescue and Life Dynamics to close abortion facilities by collecting information on the unlawful practices that occur daily in these facilities and bringing them to the attention both of state agencies and also of the employees of these facilities, warning such employees that they too can face legal trouble if they do not blow the whistle on the illegal practices that they notice in these facilities.

2-Pain Capable Unborn Child Protection Act - Priests for Life, Inc. provided strong educational support for the Pain Capable Unborn Child Protection Act, passed in May by the US House of Representatives and also enacted in about a dozen states. This measure that protects unborn children after 20 weeks due to the child's capacity to feel pain. We are now working to have the measure passed in the US Senate as well.

3-HHS Lawsuit Project Continues - Priests for Life, Inc. was the fourth group to launch a federal lawsuit against the "HHS Mandate". We received adverse rulings in both the District Court and the US Court of Appeals for the DC Circuit. On May 20, the appeals court denied our request for an en banc hearing of the case. Therefore, we appealed to the US Supreme Court, within the 90-day window that we have to make such an appeal. We have already made the firm decision that if the Court does not take our case, or if it eventually rules against us we will exercise civil disobedience against the mandate.

4-World Meeting of Families in Philadelphia - Priests for Life, Inc. presented to the Pontifical Council for the Family, and to Archbishop Charles Chaput a letter signed by 70 leaders of national pro-life organizations expressing support of the Church's efforts on behalf of the family, and specifically pledging collaboration in the World Meeting of Families in Philadelphia in September, 2015. In response, Priests for Life, Inc. was invited to organize a pro-life event during the course of the World Meeting of Families. This evening event brought numerous pro-life leaders and groups together from across the nation and around the world, and will emphasize how the affirmation of family means the affirmation of the rights of its youngest members.

5-Society of Centurions - For the last twenty years, Priests for Life, Inc. has been working with medical professionals to develop a program of healing for former abortionists and their staff. The "Society of Centurions," founded in 1996 by Canadian psychiatrist Dr. Philip Ney, has been guiding such people to healing ever since. In August 2015, Dr. Ney, in conjunction with the Priests for Life, Inc. team, offered a week-long rehabilitation session for those who have left the abortion industry.

6-Jubilee Year of Mercy - Two years ago, Priests for Life, Inc. began presenting its travels around the country as "Missions of Mercy," because pro-life effort to save the lives of the weakest among us is an expression of mercy, and the efforts we coordinate to heal people wounded by abortion (particularly through Rachel's Vineyard and Silent No More) are the most urgent expressions of mercy towards sinners. The Extraordinary Jubilee Year of Mercy, began on December 8, 2015 and continues until November, 2016. Fr. Frank Pavone, National Director of Priests for Life, conducted interviews, for our EWTN program Defending Life, with some of the Church's top experts on Divine Mercy, such as Father Seraphim Michalenko, MIC, Fr. Kazimierz Chwalek, MIC, and Dr. Robert Stackpole. Priests for Life, Inc. continued to undertake various educational and pastoral initiatives to highlight the connections between mercy and the pro-life commitment, starting with commentaries on the document Misericordia Vultus and showing how it points to the need of mercy for the most helpless.

7-Reversal of RU-486 - The abortion technique of RU-486 involves taking two distinct drugs separated by a short period of time. The circumstance arises regularly that mothers take the first drug and then change their mind about aborting their child prior to taking the second drug. One of our medical advisors at Priests for Life, Inc., Dr. Matt Harrison, encountered this situation in his office, and by necessity experimented with successful results on a progesterone protocol to reverse the effects of the first drug in the RU-486 combination and save the life of the child. Since then, and in collaboration with other physicians, this protocol has been developed, and a medical kit now made available to physicians to reverse the deadly effects of this abortion procedure. Priests for Life, Inc. collaborated with these physicians to educate both the public and the medical profession about this. In February of 2015, we held a press conference in conjunction with AAPLOG (the American Association of Pro-life Ob-Gyns) at the National Press Club in Washington, DC. Various physicians spoke about this medical breakthrough, and one of the couples who utilizes this protocol -- and their child who was saved -- were part of the press conference. 8-National Day of Remembrance for Aborted Children - In conjunction with two other national organizations, Priests for Life, Inc. sponsored the National Day of Remembrance for Aborted Children on September 12, 2015. At over 40 different gravesites throughout the United States, where tens of thousands of aborted children are buried, simultaneous memorial services are held on that day. Leading up to this observance, educational efforts focused people on how these burial places came to be, how the babies were found, and how they were killed in the first place.

9-The Gosnell Babies - In conjunction with the leadership of several denominations, Priests for Life, Inc. continued to call upon the Philadelphia Medical Examiner to release for burial the bodies of several dozen children aborted by Kermit Gosnell, now serving life sentences in prison for having killed some of them after birth. This effort not only respects the right of these babies to a proper burial but likewise educates the public about the nature of the abortion industry as revealed in the grisly details of the trial and conviction of Gosnell two years ago. On the Feast of the Ascension in 2013, Priests for Life, Inc. had a public ceremony in which names were bestowed on these children. We look forward to having a very public, multi-state national funeral for them as well.

10-Prayer campaigns - We continued our campaign to mobilize believers to pray each day for an end to abortion. We do this by means of a daily prayer to end abortion, and at special times, by means of seasonal prayers and novenas. The prayer website www.PrayerCampaign.org provides the faithful with specific pro-life prayers related to liturgical seasons, pro-life feasts, and other significant occasions. The prayers are made available in English and Spanish. We also make available prayer cards for certain of these occasions throughout the year.

11-Pro-life Day of Silent Solidarity - Our youth department, under the direction of Bryan Kemper, conducts each year, on the third Tuesday of October, the "Pro-life Day of Silent Solidarity," on which students commit to be totally silent all day as a sign of their solidarity with children in the womb. When someone attempts to speak with them, they hand them a flyer explaining abortion and the reason they are silent. Many lives have been saved as a result of this project.

12-Pro-life Leadership Coalition - Priests for Life, Inc. has developed the "Pro-life Leadership Coalition," through which we continue to convene meetings and retreats both private and public, conference calls and webcasts at strategically valuable times, to bring pro-life leaders together to work in unity and to discern joint action that they can take, as well as to keep each other informed of various initiatives they are taking.

13-Healing the Shockwaves of Abortion - In January 2015, Priests for Life, Inc., through its Silent No More Awareness Campaign (a joint project with Anglicans for Life) launched a campaign called Healing the Shockwaves of Abortion. It promotes educational and pastoral activity based on the fact that every abortion impacts multiple groups of people: not only baby and parents, but also grandparents, siblings, friends, abortion providers, pro-life advocates, and our entire society. Since the wound is multifaceted, so is the healing. Nobody can be healed from abortion in isolation. The healing must extend to all of the relationships the wounded person has. We all heal together. Each month we focus on a special target group that has been directly impacted by abortion loss, with helpful information, resources, and abortion-recovery programs. The website is www.AbortionShockwaves.com.

14-African American Outreach - 2015 was a very productive year for AAO Director Alveda King and the AAO team. Partnering with different people and organizations, we've been able to reach many individuals and educate, inform, inspire and activate the people regarding the facts about abortion as relates to civil rights, the effects of abortion on individuals, the family, and the community and finally, the help that is available for healing after abortion. Alveda took 92 trips to 52 different cities in 21 states and traveled to Canada as well. She had over 150 interviews on television, radio, the internet as well as print media doing magazine and newspaper interviews. Alveda issued 61 Press Releases and Media Alerts through Christian Newswire, Christian News Service and email blasts to a friendly media list. AAO was blessed to journey to Selma, AL for Juneteenth this year. The song PRAY FOR AMERICA was released during this event. On August 28, 2015 AAO participated in the Selma March with Glen Beck promoting the pro-life message and re-branding our message as Civil Rights for the Unborn.

15-Parliamentary Network for Critical Issues - Under the umbrella of "Gospel of Life Ministries" we have continued to assist in the operation of the Parliamentary Network for Critical Issues. In 2015 PNCI continued to share global news related to life issues, recommended best pro-life practices to save the lives of mothers and preborn children from abortion, including model laws and policies that restrict, regulate, and reduce abortion, and alerted contacts to pro-abortion tactics suggesting counter measures and joint actions. PNCI maintains close collaboration with parliamentarians, staff and NGOs in the U.S. and Canada and at the European Parliament, Council of Europe, and the Parliamentary Assembly of the Organization for Security and Cooperation in Europe and monitors actions affecting respect for life at the United Nations and Organization of American States. PNCI is a recognized source for global pro-life news with its articles appearing in 2015 on pro-life and religious news sites including Zenit, Catholic New Agency, Lifenews, and news by the National Right to Life Committee.

16-Rachel's Vineyard - The ministry of Rachel's Vineyard continues to be the largest pro-life outreach around the world for healing after abortion. It operates with the assistance of Priests for Life, Inc. and utilizes a retreat model based in Scripture and the sacraments.
