Our programs highlight local folklore and cultural heritage and include field research, the presentation of Washington traditional artists in performances, festivals, workshops, exhibits, school presentations, and various publications. Public programs take place in venues located in all regions of the state, and are run in partnership with local arts & cultural organizations, historical societies and museums, chambers of commerce, Lions' Clubs, Washington State Parks, and other community-based groups. Audiences range from 10 people for a hands-on craft workshop, to 100 - 200 for a performance in a small venue, to thousands for a festival setting or one of our publications or radio or TV broadcasts. We have made a special effort to outreach to rural and under-served communities in Washington, and we both document and present many different ethnic and occupational artists and tradition bearers who represent a wide range of cultural communities. Our publications have included our cultural heritage audio driving tours to different regions of Washington state and our Native American legend recordings.
