Our programs and service engage young students in powerful learning across the curriculum by helping teachers and scientist & engineer volunteers plan and implement exciting STEM learning experiences that take advantage of the wealth of local science, engineering, and environmental education resources.

Teacher Services: CRS provided over 1,600 Kindergarten through 8th grade teachers with comprehensive information, references, personalized support, web-based resources, training, workshops, and other support related to science teaching and learning. CRS served classroom teachers in 130+ schools in the East Bay including Oakland, Emeryville, Berkeley, and West Contra Costa. CRS provided teachers with on-call planning support, custom research reports, and responded to hundreds of individual teacher requests. CRS provided workshops addressing science and engineering teaching practices, content, curriculum, and new science standards. Together, the teachers we serve educate over 30,000 students, mainly in high-need, under-resourced urban schools. Through our Science Super Star Challenge, we recognized over 100 teachers for excellence in elementary science teaching, awarding prizes such as field trips, assemblies, books, and classroom supplies. Information services include comprehensive online resources, monthly email bulletins, quarterly resource reports, newsletters. We hosted two free teacher events in partnership with local science centers, connecting teachers with a range of support organizations and educational service providers, and highlighting resources such as field trips and in-class programs. Our ESCAPE collaboration in WCCUSD engaged 100 educators in professional development.

BASIS -- Bay Area Scientists in Schools: The BASIS program recruited, trained, and placed 550 STEM professionals into Kindergarten through 8th grade classrooms to present engaging, standards-based, hands-on science lessons. Scientists and engineers serve as diverse, enthusiastic role models who inspire young students to learn about academic and career options in science and engineering. Scientist volunteer teams presented over 500 lessons in classrooms in 2015, engaging over 12,000 students in science learning. Lesson plans, material, resource information, science content background, and teaching strategies are made available to classroom teachers, encouraging pre- and post-BASIS visit explorations, investigations, and design challenges in order to extend the learning. Lessons are archived and available on the CRS website.

Resource Development: Convening, consulting, and training projects targeting challenges and opportunities in K-8 science education. CRS provided professional development and curricular development services to schools, districts, and informal education organizations. CRS coordinated site-based pilot projects involving middle school science support linking scientists with 7th grade classrooms, providing mentorship as students conducted independent investigations. The CRS Advisory Council on Elementary Education brings together thought leaders from industry, academia, school districts, informal education organizations, scientists, engineers, teachers, and others working to improve K-8 science education.
