The goals of Strong Families are to change the way people think about, feel about, and act in support of families of all kinds, build strong alliances across social justice sectors to expand the initiative's base of power, change policy on the local, state, and national levels to benefit the majority of families and, mobilize communities to take action for issues impacting families facing the greatest challenges and discrimination.

Developed the leadership of 60 young Asian women and men in Oakland, CA, to advocate on behalf of their communities.
