The Farm Opportunities Loan Program provides financing to underserved, immigrant and beginning farmers. The program serves borrowers who would otherwise have difficulty securing financing due to limited business history, limited traditional collateral, little credit history, small loan sizes, or language barriers. FarmLink also directs farmers to other financing as necessary. FarmLink closed 50 loans in 2015 totaling \$1.8 million. 74% were for beginning farmers, 68% were Latinos and 36% women. These loans retained 261 jobs and created 55 new jobs. Pathways to Ownership helps farmers plan for low-interest mortgages often made in collaboration with other lenders.

The Land Access Program maintains an active database of land available throughout California and provides a platform for beginning farmers to share their qualifications. The program connects farmers and landowners, develops good leases, and supports land purchases. In 2015 FarmLink launched Agrarian Elders and the Next Generation, to provide assistance in business succession planning. Since 2011, FarmLink staff have developed 166 successful leases or purchases. During 2015, FarmLink provided personalized advisory services to 344 farmers and landowners. 72% of this assistance supported low-income farmers and 40% of clients were women.
