The objective of the protected repository for defense of infrastructure against cyber threats (PREDICT) is to design, develop and implement a large-scale, privacy-protected dataset repository of real network and system traffic for use by the cyber research community, both in the US and internationally. PREDICT will accelerate design, production & evaluation of next generation cyber security solutions including commercial products. The scope of the work performed by PCH is as both data host and data provider.

4b (Code:) (Expenses \$ 741,449 including grants of \$) (Revenue \$)
Packet Clearing House provides equipment, training, data and operations support to organizations and individual researchers seeking to improve the quality, robustness and accessibility of the internet. Current and on-going PCH projects include the construction of internet exchange points throughout the developing world; support for globally distributed domain name systems' resources; implementation of network research data collection initiatives in more than three dozen countries and the development and presentation of educational materials to foster a better understanding of internet architectural principles and their policy implementations among policy makers.

Real time geographic mapping and characterization of internet connectivity outages is a new project for PCH in 2015. PCH will work to enhance the existing status monitoring prototype capability to present real time visualizations of internet outages, mapping them geographically and characterizing them by identifying affected networks and quantifying the number of affected users. The visualization will be provided as a real-time feed that can be received and continuously updated through a web browser, typically in a kiosk configuration which could be projected as a status screen on the wall of a network operations center.
