Approximately 2,500 people benefited from the CAAAE's services in 2015. That includes sponsorship of the annual awards ceremony of the Santa Clara County Alliance of Black Educators (SCCABE), San Jose State University's African American College Readiness Summit, the annual science fairs for the Dr. Frank S. Greene Scholars Program (GSP) and the Dr. George Washington Carver Scholars Program (CSP), as well as Dinner with the Scientists. The GSP also hosted week-long summer science institutes in partnership with Texas Instruments and Cisco Systems. Project WORD (Working on Redefining our Destiny) served students at Oak Grove, Santa Teresa and Mt Pleasant High Schools and sponsored Open Mic at Andrew Hill, James Lick, Silver Creek, Piedmont Hills, Evergreen Valley and Overfelt High Schools.
