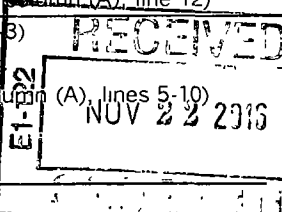

The funds provided by the Doyle Trust to the City of Santa Rosa are used to maintain Doyle Park, an essential governmental function.

The Doyle Scholarships are well-known within the community and have allowed three generations of families to attend the community's highly rated and highly regarded junior college. The Trustees of the Trust work closely with the District to define and address the District's needs. In addition to the distribution of funds, the Trust performs important functions on behalf of the Santa Rosa Junior College District that would otherwise be performed by the District, including the implementation, maintenance and operation of the highly specialized and time-consuming Doyle Trustee Awards Program, by which the Trust is solely responsible for the review, selection and award of scholarships to worthy students whose challenges and struggles most
