CMA Foundations programs are designed to provide California physicians and other providers with the necessary tools and resources to enhance their effectiveness in achieving optimal health and well-being for their patients. Through its one-of-its-kind Network of Ethnic Physician Organizations (NEPO), a coalition of more than 50 ethnic physician organizations from across California, CMA Foundation is uniquely positioned to help decrease health disparities among California’s growing ethnically and racially diverse populations. Community HealthAlliance Working for Antibiotic Resistance Education (AWARE) Project For over 20 years, AWARE has been a national leader in addressing antibiotic resistance and appropriate antibiotic prescribing. -The AWARE expert clinical workgroup convenes to develop timely educational materials, commonly known as the AWARE Toolkit, which promote the appropriate use of antibiotics in English and Spanish. -AWARE launched the AWARE Toolkit mobile app to provide easy access to the project’s Adult and Pediatric Acute Respiratory Tract Infection Guidelines, which has been downloaded by thousands of providers in countries across the world. -The AWARE Project was cited as a Best Practice on appropriate treatment for children with viral upper respiratory tract infections by the California Department of Health Care Services. -The AWARE Project’s Clinical Toolkit is utilized in 15 other states across the nation and is featured on the American Medical Association’s website. The Network of Ethnic Physician Organizations (NEPO). NEPO brings together more than 50 ethnic physician organizations from across California to create an empowered, unified voice of ethnic physicians and their organizations to promote diversity, access, and quality, in healthcare. NEPO is designed to identify strategies for building the capacity of Ethnic Physician Organizations, address health disparities and the social determinants of health, improve workforce diversity, engage in leadership development and to encourage physicians and other providers to be community advocates. NEPO took a lead role in outreach and providing education to ethnic physicians and communities of color regarding the Coordinated Care Initiative. -Annual NEPO Summit brings together nationally recognized policy leaders, elected officials and physician leaders. This successful Summit draws over 250 physicians, other providers, and policy experts to learn best practices, share information, and network. As part of the grant, the CMA Foundation coordinated statewide provider education by partnering with county medical societies and ethnic physician organizations. Physician Leadership Awards, Grants, and Scholarships. The CMA Foundation encourages physician leadership by recognizing outstanding accomplishments and leadership achievement by physicians and organizations working to improve health access and increase quality of care for Californians. -The Robert D. Sparks, MD Leadership Award is given annually to an individual or organization that has demonstrated extraordinary interest in and efforts to improve community health, consistent with the mission of the CMA Foundation. -The Adarsh S. Mahal, MD Access to Health Care and Disparities Award was established by 2007 CMA President Anmol S. Mahal, MD and his wife Surgit K. Mahal, MD to honor an individual or organization that has demonstrated extraordinary interest and efforts toward improving access to health care or reducing health care disparities in California. -The Frank E. Stagers Sr., MD Outstanding Ethnic Physician Organization Award was established in honor of Dr. Stagers Sr., Co-founder of the Network of Ethnic Physician Organizations (NEPO). The award honors an ethnic physician organization that has taken significant action improving the health of their communities.
