At the press of the medical alert button, the Lifeline 24-hour emergency response team is activated. Lifeline saves lives in the event of an emergency, reduces suffering and fear, and provides for early intervention in the event of a fall. There are greater than 700 clients currently receiving Lifeline services. The Service League started a financial assistance program that offers the service at a reduced fee. Our financial assistance program is currently providing financial assistance for approximately 65 clients who otherwise could not afford the service. The Service League recognizes their social responsibility to address the needs of the at-risk elderly and disabled members of our community, and those with limited financial resources.
