Golf for Greenville was developed and founded by Fluor employee volunteers in 1989. Since its inception, this employee-led initiative has had a strong impact on the Greenville community. Countless volunteer hours go into organizing the tournament and soliciting donations. Recent years' Golf for Greenville events have had overwhelming support from Fluor employees and vendors, and frequently sell-out the tournaments. In 2015, a total of \$443,500 was donated from Golf for Greenville bank account to 1) Goodwill Industries, \$153,525; 2) The Family Effect - Serenity Place, \$98,375; 3) Meals on Wheels, \$64,603; and 4) Safe Harbor, \$126,997.

Fluor Cares team in Sugar Land, TX coordinates an annual golf tournament with Fluor Executives, Clients, and Vendors which raised funds for four (4) non-profit organizations: 1) Life House of Houston, \$66,085; 2) Pecan Grove Volunteer Fire Department, \$66,085; 3) Lunches of Love, \$56,085; and 4) United Service Organization (USO), \$66,085. Funding for the Grants was raised through tournament fee fees, tournament dinner and silent auction.

**4c** (Code \_\_\_\_\_) (Expenses \$ 73,131 including grants of \$ 7,049 ) (Revenue \$ 71,261 )

Building Futures is an annual community outreach project in which Fluor Cares teams provided backpacks filled with school supplies to schools and youth organizations benefiting children in grades K-5. Fluor employees donated school supplies and money to fill backpacks and provide classroom supplies. Backpacks were filled with school supplies and donated to Irving ISD in Dallas, TX. Funds were also issued as a grant to Irving Independent School District, \$4,450.96. 1,000 students were provided with school supplies to begin the school year, and a backpack was provided to every child at West Cliff Elementary in Berea, SC, as well as to Communities in Schools and Boys and Girls Club. 1,083 backpacks filled with school supplies were distributed to three schools in Houston, TX. Each school also received a grant payment of \$865.93 to be used for STEM related activities. 1,000 backpacks filled with school supplies were donated to underprivileged chil.
