The Healthcare Foundation at GAMC provides a fund raising function to support the mission of Glendale Adventist Medical Center and programs to improve the quality of life and health in our community. The funds are transferred to the hospital based on the grantors and donors intent. A significant portion of Management and General expenses are paid for by Glendale Adventist Medical Center and accounted for as a department of the hospital in its support of the Foundation. The following story illustrates how the Foundation is able to support the mission of Glendale Adventist Medical Center. One in eight women in the United States will be diagnosed with breast cancer in her lifetime and it is the second leading cause of death among women. A cancer diagnosis changes a persons life forever. It is frightening and stressful but no one needs to go through this journey alone. Thankfully, because of the advances in healthcare and quick response of talented physicians, Glendale Adventist Medical Center was able to help Elen Tahmasian become one of the over 2.8 million breast cancer survivors in the United States today. The GAMC Cancer Center provides free cancer support services to cancer patients and their families regardless of where they received treatment. Programs such as support groups, yoga classes, art classes, and positive image services are available because of the generous donations to the Healthcare Foundation and the tremendous fundraising efforts of the GAMC Cancer Care Guild. Like many other women who receive chemotherapy and radiation as a part of their treatment, Elen lost her hair and struggled with the emotional side effects of seeing what seemed like a different woman in the mirror. One of the support services the GAMC Cancer Center provides is the Positive Image Center which provided women with free wigs, hats, scarves and knitted caps. Elen was able to use the Positive Image Center which gave her a huge boost to her personal self worth and helped her through her treatment and recovery. Compassionate, high-quality patient care, life-saving and life-preserving medical and surgical services, advanced treatments in a community-based hospital, essential emergency services- these are the reasons our donors choose Glendale Adventist Medical Center as their charity of choice.
