DURING 2015, A WINDOW BETWEEN WORLDS (AWBW) REACHED OVER 23,800 WOMEN, MEN AND CHILDREN WITH TRANSFORMATIVE ARTS PROGRAMS THAT EMPOWER INDIVIDUALS AND COMMUNITIES IMPACTED BY VIOLENCE AND TRAUMA. AWBW FACILITATED THE USE OF ART AS A CATALYST FOR TRANSFORMATION WITHIN A LIFE CHANGING SPACE FOR SAFETY, CONNECTION AND HEALING AT 361 COMMUNITY SERVICE AGENCIES THROUGHOUT LOS ANGELES COUNTY, CALIFORNIA AND 27 ADDITIONAL STATES. WE MADE ARTS PROGRAMS ACCESSIBLE WHERE THEY MIGHT NOT OTHERWISE BE AFFORDABLE BY SERVING AS A HUB OF INNOVATION, PARTNERING WITH A VARIETY OF HUMAN SERVICE AGENCIES. AWBW HELPED BUILD THE CAPACITY OF THESE AGENCIES BY TRAINING STAFF TO DEVELOP AND LEAD WEEKLY TRAUMA-INFORMED ART WORKSHOPS, OFFERING ONGOING SUPPORT AND CONNECTING THESE TRAINED WINDOW LEADERS WITH OTHERS DOING SIMILAR WORK. DURING 2015, AWBW BEGAN NEW ART PROGRAMS AT 42 SITES. AN ONGOING NETWORK OF OVER 640 TRAINED ADULT LEADERS AND 533 TRAINED CHILDREN'S LEADERS PROVIDED OVER 12,000 WORKSHOPS DURING THE YEAR FOR WOMEN, MEN AND CHILDREN IMPACTED BY VIOLENCE AND TRAUMA. AWBW'S PUBLIC EXHIBITIONS REACHED OVER 6,000 VIEWERS AT 23 VENUES DURING 2015, RAISING AWARENESS ABOUT THE IMPACTS OF VIOLENCE AND TRAUMA THROUGH THE VOICES OF THOSE WHO EXPERIENCE IT FIRST-HAND. AWBW CONDUCTED OVER 120 OUTREACH WORKSHOPS AND PRESENTATIONS WITH OVER 5,000 PARTICIPANTS IN COMMUNITIES THROUGHOUT LOS ANGELES COUNTY AND NATIONWIDE.
