Immigrant integration In 2015, LA Voice leaders reached 4,200 immigrant community members with workshops on citizenship, DAPA, DACA, obtaining a drivers license, and health care coverage, worked with the county and service providers to improve life for the undocumented, including working with the LAPD to reduce deportations of aspiring Americans and working with the LAPD and HACLA to ensure the continued success of a farmers market in the food desert community of Ramona Gardens, and organized on the state level to pass a bill that provided Medi-Cal to undocumented children

Criminal justice and re-entry LA Voice supported formerly incarcerated Angelenos in becoming more job-ready by working to facilitate record changes through Prop 47, maximize the benefits of Prop 47, and increase access to jobs for those with criminal records We hosted a Live Free Town Hall that was attended by 900 people and Sup Solis and Board of State and Community Corrections chair Linda Penner, which resulted in a County motion that created two committees to strengthen Prop 47 implementation and conducted an internal audit of county Prop 47 savings The audit led to \$13 million reinvested in re-entry, record change, and rehabilitation We lead the coalition that advanced the Fair Chance Initiative, which will open up job opportunities for thousands Grassroots parent leaders also helped win an \$8 million dollar increase in restorative justice dollars for our most challenged schools
