Voter Protection In 2015, Advancement Projects Voter Protection Project continued to work with grassroots partners representing communities of color in dismantling barriers to the ballot box, especially in advance of 2016, which will be the first presidential election without the full protections of the Voting Rights Act since it was enacted in 1965 We confronted a rising tide of attempted discrimination in voting, and had some victories, while seeing the need for continued and increased long-term voter protection work with our grass-roots partners in this climate Our team of seasoned voting rights lawyers filed litigation, monitored election administration, educated our partners and corrected some problems as they arose We worked in Arizona, Florida, Georgia, Missouri, North Carolina, Ohio, Wisconsin and Virginia, investigating voting changes such as strict voter ID laws, cuts to early voting, moving polling places, initiating new forms of purging, changing voter challenge rules, registration procedures, and limiting access for Spanish-speaking voters We were leading co-counsel on an amicus brief before the Supreme Court in the Evenwel redistricting case, which posed an extreme threat to the potential political power of communities of color, and recently received news that the Court agreed with our constitutional analysis and rejected the dilution of voting rights 8-0

Schoolhouse-to-Jailhouse Advancement Projects Ending-the-Schoolhouse-to-Jailhouse Track Project focused on ending harsh discipline and the criminalization of children of color, greatly improved education outcomes in 2015, and continues to do so in several school districts, including in Colorado, New York, Mississippi, and Florida Additionally, we support the national movement to end the school-to-prison pipeline by working alongside national stakeholders, as well as on the ground with local partners by offering communications, legal, policy, and organizing support to grassroots groups in states across the country, which includes bringing the issues that affect young LGBTQ people of color into the school-to-prison pipeline discussion
