INPEACE recognizes the financial statement benefit from a tax position only after determining that the relevant tax authority would more likely than not sustain the position after an audit based on the technical merits of the position. INPEACE has not identified any uncertain tax positions in filed returns that require disclosure in the accompanying financial statements. INPEACE is generally not subject to income taxes in the U.S. federal jurisdiction and the State. Tax regulations within each jurisdiction are subject to interpretation of the related tax laws and regulations and require significant judgment to apply.
