Hosted 1 medical missionary team with volunteer medical providers and 1 Wake Forest University medical student for an international medicine rotation. We have a Dominican National medical doctor volunteering in our medical clinic that we provide housing for. We hosted one nurse volunteer to train our volunteer Dominican Doctor in Women's Health care. The Medical Program also continues to provide a scholarship for a local Dominican to attend dental school in Santo Domingo. The Sports and Community Outreach Program hosted a Dominican church that used the facility for community evangelistic outreaches each month. The Sports Program provided a scholarship for a Dominican National to attend the Wendelstedt Umpire School in Daytona Beach Florida.
