Peru Volunteer Program. In 2015, 98 volunteers participated in our volunteer program, which is oriented towards fostering understanding of Peruvian culture as well as professional development in the areas of medicine, music, education and engineering. We executed 8 medical campaigns serving 650 patients and invested more than 11,400 volunteer hours in community outreach to our projects in Peru. Volunteers also participated in health prevention and education workshops reaching 300 community members as well as Christmas events where toys were distributed to children in the community. Volunteers also traveled to Cusco to visit Machu Picchu and learn about the roots of the Incan culture and appreciate the rich history of Peru.
