CEOGC's Early Head Start Program incorporates the belief that education starts when life begins. CEOGC is a strong advocate for the youngest of children and those who have not even been born yet. CEOGC served 140 infants, toddlers and pregnant women, through the Early Head Start program. The program provides prenatal examinations, parenting classes, and quality infant care to eligible families.
