The PCMP provides medical, operations and pharmaceuticals support for a system of 5 hospitals, 108 clinics and a nursing school in the remote villages of northwest DR Congo. Special needs are also supported through donated medical equipment and supplies including donated eyeglasses. Medical professionals give extensively through the PCP Medical Ambassadors teams including consulting, focus groups and bi-annual teaching training trips. PCP is continuing the agricultural microfinance project that was started in partnership with USAID, helping subsistence farmers to grow cash crops and to develop wholesale distribution channels.
