THE N A T I V E PROJECT PROVIDED PRIMARY MEDICAL CARE, ALONG WITH A DIABETES PROGRAM, LIMITED ADULT COUNSELING SERVICES, DENTAL SERVICES, AND PHARMACY SERVICES TO A PRIMARILY LOW INCOME/UNDER-SERVED POPULATION. THE N A T I V E PROJECT PROVIDES CARE TO PERSONS COVERED BY GOVERNMENTAL PROGRAMS AT BELOW COST AND TO INDIVIDUALS WHO ARE UNABLE TO PAY. THE UNREIMBURSED VALUE OF PROVIDING CARE TO CLINIC PATIENTS DURING THE FISCAL YEAR WERE 114,557 FOR CHARITY CARE, 168,714 FOR MEDICARE, AND 70,237 FOR OTHER THIRD PARTY PAYORS. THE N A T I V E PROJECT HAD 8,482 MEDICAL VISITS, 3,054 MENTAL HEALTH VISITS, AND 3,176 SUBSTANCE ABUSE VISITS, 320 DENTAL VISITS, 90 LEADERSHIP CAMP PARTICIPANTS, 83 SUMMER PROGRAM PARTICIPANTS AND 1,216 WELLNESS PROGRAM PARTICIPANTS DURING THE FISCAL YEAR.
