The organization provides assistance to veterans in the following ways. First, the organization hosts job fairs and career counseling workshops that connect veterans with employers, as well as work one-on-one with veterans at the office to provide direct employment assistance to veterans looking for work. Next, the organization hosts various homeless outreach events to provide at-risk homeless veterans essential services, food, clothing and access to housing. In addition, the organization provides direct support to homeless and at-risk veterans, including emergency financial assistance and gift cards to families in need during the holiday season. Lastly, the organization helps veterans navigate the Veterans Administration (VA) benefits and other veteran services to secure benefits, as well as offer legal referrals to veterans facing matters within the civil and criminal court system.
