IN ADDITION, FIVE COMMUNITY SERVICE PROJECTS RECEIVED FUNDING. MTF ALSO PROVIDES CASE REPORT AWARDS FOR BOTH STUDENTS AND PRACTITIONERS. IN 2015-16, THREE PRACTITIONER AWARDS WERE FUNDED. THE MTF CONTINUES TO FUND THE INTERNATIONAL JOURNAL OF THERAPEUTIC MASSAGE & BODYWORK (IJTMB) WHICH IS OPEN ACCESS, PEER-REVIEWED PUBLICATION INTENDED TO ACCOMMODATE THE DIVERSE NEEDS OF THE RAPIDLY-EXPANDING THERAPEUTIC MASSAGE AND BODYWORK COMMUNITY THAT IS OFFERED TO READERS, FREE OF CHARGE, ON A QUARTERLY BASIS.
