THE FOUNDATION AWARDED COLLEGE SCHOLARSHIPS TO TWO GRADUATING STUDENT-ATHLETES AT LAKE BRADDOCK SECONDARY SCHOOL.

THE MIA HAMM FOUNDATION AWARDED SIX GRANTS TO RAISE AWARENESS AND PROVIDE SUPPORT FOR BONE MARROW AND CORD BLOOD TRANSPLANT PATIENTS AND THEIR FAMILIES. THIS YEAR'S GRANT RECIPIENTS INCLUDED ORGANIZATIONS THAT WORK TO RAISE AWARENESS OF THE NEED FOR MORE BONE MARROW DONORS AND ORGANIZATIONS THAT PROVIDE HOSPITALITY HOUSES WHERE PATIENTS AND FAMILIES CAN STAY AFTER A BONE MARROW TRANSPLANT.
