The Shop With The Sheriff Program is an annual Holiday program that is funded by a combination of member dues and donations from the community to assist indigent children and their families in purchasing clothing, school supplies and other necessities over the holiday season. Indigent children and their families are recommended by local governmental and private social service agencies as qualifying for federal assistance and worthy of support from the public assistance programs.

4b (Code:) (Expenses \$ 16,332 including grants of \$) (Revenue \$)

The Fourth Street Corridor Program was split off from the Shop With The Sheriff Program during this fiscal year. The Program is similarly funded and seeks to provide assistance to indigent children and their families living in the low-rent, impoverished inter-city corridor of Reno and Sparks.

4c (Code:) (Expenses \$ 5,333 including grants of \$) (Revenue \$)

The K-9 Unit acquisition program is a cooperative effort between the Association and Washoe County to provide an on-going program to acquire and train canines as replacement dogs for the agency's K-9 Unit. The Program is funded by member dues and community donations which go toward acquiring, training and equipping the canine. Washoe County pays for the wages, benefits, travel and per diem costs for sending a Deputy Sheriff back to Indiana for the intensive training course with the new canine.

All requests for funds from the Washoe County Sheriff's Office for equipment, supplies and training that are approved by the executive staff are paid directly to the equipment, supply or other provider. All funds donated to charitable organizations are paid directly to the local chapter of the organization for use in the community. The Shop With The Sheriff and Fourth Street Corridor Programs for indigent children are supervised by the volunteers from the Honorary Association and the Washoe County Sheriff's Office employees. The programs support indigent children and their families who are nominated by various local public and private charitable organizations as qualifying for federal assistance. No public grant funds are obtained or distributed by the Honorary Association. All dues/donations/grants are reported to the membership with the membership providing input in regard to potential projects to support. Individuals receiving training are typically scheduled to appear before the Association members to relate their experiences at the training facility with live demonstrations by the K-9 Unit dogs and static displays of new equipment conducted at meetings of the Association.

The first quarter membership meeting has traditionally been a Mystery Dinner where the Forensic Science Division professional staff write and present a forensically based mystery to the members with the third quarter membership meeting devoted to a BBQ and awards presentation to heroes' from law enforcement and the community who have distinguished themselves during the prior year.
