Provide housing, assisted living and skilled nursing services which include food services, housekeeping, and nursing care. During FY2016 we served an average of 230 residents with a total of 6,175 service days of skilled nursing, 7,848 service days of assisted living, and 62,354 days of residential care services. Channing House is a neighborhood polling location, hosts various community meetings including educational sessions on End of Life planning (ELIPSIS program), and partners in emergency preparedness programs. We provide the use of our swimming pool to a local not-for-profit that serves developmentally disabled children. Our community also tutors children from disadvantaged neighborhoods, and supports many other organizations with thousands of hours of volunteer time.
