As part of our support for other local greater Rochester 501 (c) (3) organizations, we hosted several evenings in our store where their volunteers may shop and we then donate 20% of such sales to their organizations This year proceeds went to GRMOTC, Helendale PTA, Rochester Montessori, Angels of Mercy, PEO, First Unitarian, City Waves Swim Team and RAIHN

The second part of our mission is to educate Americans living in the greater Rochester area about the issues related to global poverty and fair trade Our volunteers serving in our Speaker's Bureau visit schools, churches, and civic organizations to make presentations on these topics This year's talks were to PEO group, Girl Scouts group, newly hired volunteers, Nazareth College, Livonia 5th graders and students from St John Fisher College
