Three Strand Cord weaves together sustainable communities built on a strong Biblical foundation. Three Strand Core equips these communities by setting into motion seven spokes of independence: clean water, renewable food, appropriate education, available medical care, a viable economy, reliable power and Biblical discipleship. Three Strand Cord also partners with growing organizations and mission teams who can benefit from the experience and resources available through Three Strand Cord.

OASIS PROJECT: 3SC partners with local communities in international locations to secure seven basic elements of self-sufficiency: clean water, renewable food sources, available medical care, appropriate education, a viable economy and Biblical discipleship. In 2015, 3SC finished installation of a water machine which produces enough clean water to provide for the water needs of 5,000 people per day. During a cholera outbreak near this community, the community was able to provide water to surrounding communities, and 3SC sent supplies to treat 300 infected patients. Also, 3SC provided 120 primary school scholarships which provides all the school needs for each child including tuition, uniform, books and any meals provided by the school. As part of the economic initiative, 3SC provided 3 microloans allowing for the economic advancement of three families.

4b (Code:) (Expenses \$ 54,530 including grants of \$ 11,821) (Revenue \$ 0)

SHORT TERM TRIP SUPPORT: 3SC supports churches within the United States who have long assisted international communities by sending short-term mission teams to accomplish specific goals. Through these teams, the communities can access resources, knowledge and man-power previously unavailable to them. Often, the members of these short-term mission teams make connections that grow into larger commitments; in fact, 3SC has seen numerous groups being to work toward Oasis Project goals that began with a short-term visit. 3SC aids these teams by collecting funds, allowing them to access resources, and coordinating in-country efforts. In 2015, 3SC partnered with four teams travelling to the Caribbean and to South America. Through these teams, 3SC helped provide medical and dental treatment to over 2,500 individuals.

4c (Code:) (Expenses \$ 75,764 including grants of \$ 34,020) (Revenue \$ 0)

SUPPORT of GROWING ORGANIZATIONS: Leveraging its administrative capabilities, 3SC helps organizations that need support to begin or enhance their capabilities, including accounting and reporting. 3SC currently supports organizations ranging from primarily humanitarian to primarily ministerial across the globe. In 2015, supported organizations such as the Knapp Baptist Orphanage, which provides a home for over 40 orphans in Tanzania; the Pav Family, who are in training to translate the Bible into the tongues of unreached tribes; the Bast Family through Word of Life Ministries who provide discipleship programming to teens in communities of Argentina; and Sowing for Eternity which provides mentoring and discipleship to those in the Dominican Republic.

The first, direct payment to the foreign organization, requires the completion of an expenditure agreement letter after a pre-grant inquiry is completed. Secondly, Three Strand Cord makes direct payments to organizations or vendors in the United States that undertake a portion of the work being done. This includes the purchase and installation of needed equipment or purchase of needed supplies for short teams accomplishing work. Thirdly, if necessary for the fulfillment of a program aim, money is transferred to the independent contractor overseeing, on behalf of Three Strand Cord, the work being done. These contractors are thoroughly vetted and required to do extensive reporting on all financial expenditures and outcomes of each project. After any of these expenditure methods are used, reporting must be submitted by all parties as to how the money was used in completion of the missional purpose. When possible, an officer of Three Strand Cord travels to review the completed or in-progress work.
