As a result, the income, gain, loss, expenses and other similar items generated by PMG's activities will be reflected and included on separate income tax returns to be filed by PMG. This election was made due to the successful operation of PMG and the continued increase in revenues generated by PMG's activities. PMG will continue to be 100 percent owned by the College. The College follows Financial Accounting Standards Board Accounting Standards Codification guidance clarifying the accounting for uncertainty in income taxes recognized in an organization's financial statements. This guidance prescribes a minimum probability threshold that a tax position must meet before a financial statement benefit is recognized. The minimum threshold is defined as a tax position that is more likely than not to be sustained upon examination by the applicable taxing authority, including resolution of any related appeals or litigation processes, based on the technical merits of the position. The tax benefit to be recognized is measured as the largest amount of benefit that is greater than fifty percent likely of being realized upon ultimate settlement. Tax years that remain open for examination include years ended March 31, 2013 through March 31, 2016.
