FOR THE DURATION OF THE GRANT, THE LODGE PROVIDES QUARTERLY PROGRESS REPORTS DETAILING ACTIVITIES AND HOW THE FUNDS ARE USED. AT THE END OF THE GRANT PERIOD OR PROJECT COMPLETION, THE LODGE PROVIDES A FINAL REPORT AND IS REQUIRED TO RETURN ANY UNUSED FUNDS. ON-SITE VISITS BY THE FOUNDATION ARE ALSO MADE TO ASSESS THE USE OF THE AWARD.
