As a non-profit developer and partner, NHSRC has helped create and develop more than 425 units of affordable rental housing for senior citizens living in the Roseland, South Chicago, and Wrightwood neighborhoods. NHSRC's related entity partnerships own a portfolio of 295 multi-unit and 17 single-family properties. NHSRC secures vacant properties to be later used in its effort to stabilize neighborhoods by rehabbing homes and affordably selling them to homeowner-occupants
