The Good Samaritan Health Services Foundation primarily has two large fundraisers throughout the year, the annual Chanty Golf Classic and the annual Creations Auction and Dinner. Our Charity Golf Classic raises money to support a specific project each year being completed at Heart of America Medical Center. In 2015, we raised funds to renovate our hospital admissions area. The event is limited to 22 teams of 4 people per team. Area businesses and hospital vendors are asked to donate money to this worthy cause by being a sponsor at the event in the amounts of \$650 tournament sponsors, \$500 platinum hole sponsors, \$250 gold sponsors, \$100 silver sponsors, prize sponsors or team sponsors. We had a total of 115 sponsors of these various options for the overall tournament and about 100 people attended the event cookout that evening (including players). Our annual Creations Auction and Dinner raises funds for our HAMC Hospice Program. We have about 240 people that attend each year, and around 150 donations of different items that are either auctioned off through a live auction or through a Chinese raffle. The day to day activities of the GSHS Foundation includes but are not limited to writing and seeking out grants for GSHA, overseeing grant management of awarded funds, supporting fundraising projects, overseeing donor database, making sure donations received are deposited in a timely matter and coordinating the maintenance of all records including financial records. GSHS Foundation is in the community spotlight in various ways throughout the year by placing monthly thank you ads in our newspaper to all those who donate to the hospital for different departments each month, and we send out a holiday newsletter once per year to 5 surrounding zip codes to say thank you and explain the good things we have raised funds for throughout the year.
