The employees, medical staff and volunteers of Holland Community Hospital remain committed to the hospital's mission to continually improve the health of the communities we serve in the spirit of hope, compassion, respect and dignity. Our vision is to be the preeminent stand-alone hospital in West Michigan as measured by benchmark customer service, business growth, financial performance and clinical excellence. We measure our achievements against five organizational strategic essentials: financial strength, growth, quality, superior service and superior workforce. Nationally Recognized Quality. For the second consecutive year, Holland Hospital received the America's 50 Best Hospital Award from Healthgrades. This award recognized Holland Hospital as the highest performing hospital in Michigan and the 7th highest nationwide. In addition to Healthgrade's award, Holland Hospital earned a place on Truven's Top 100 Hospitals list for an 11th consecutive year. The 100 Top Hospitals award is based on performance across more than a dozen measures, including mortality, complications, length of stay, readmissions, financial performance, patient satisfaction and spending per beneficiary. Workplace Excellence. For the 14th consecutive year, Holland Hospital was named a West Michigan's Best and Brightest Companies to Work For by the Michigan Business and Professional Association (MBPA). According to MBPA, winning companies practice innovative strategies and represent best practices in human resources. The Hospital received high scores from employees on compensation, benefits and employee solutions, employee enrichment, engagement and retention, employee education and development, recruitment, selection and orientation, employee achievement and recognition, communication and shared vision, diversity and inclusion, and work-life balance. Superior Services. Holland Hospital's clinic excellence can be found across its service lines -Orthopedics. America's 100 Best Hospitals for Orthopedic Surgery for 3 years in a row. Joint Replacement. Top 5% in the Nation for Overall Orthopedic Services in 2016. -Prostate Surgery. Prostate Surgery Excellence Award in 2016. -Heart Care. Five-Star Recipient for Treatment of Heart Attack for 3 years in a row. -Stroke Treatment. Five-Star Recipient for Treatment of Stroke for 10 years in a row. -Gastroenterology. Five-Star Recipient for Treatment of Bowel Obstruction for 4 years in a row. -Critical Care. Five-Star Recipient for Treatment of Sepsis for 11 years in a row (2006-2016). Leading Edge Technology. Holland Hospital and Western Michigan Urological Associates were the first in the region to offer UroNav Fusion Biopsy, an innovative new technology for more precise and accurate detection of prostate cancer. Prostate cancer is the most common cancer in men, affecting 1 in 7, and is the second leading cause of death in men. The UroNav system advances the "active surveillance" approach of suspicious lesions in the prostate, fusing MRI images with ultrasound images during the biopsy to provide real-time visualization of the suspected lesions. This GPS-like tracking identifies suspicious areas that can be targeted during the office-based prostate biopsy, which may improve the accuracy and precision of those biopsies. Summary of Efforts During fiscal year 2016, Holland Hospital's 430-member medical staff, 2,000 employees and 370 volunteers served the community by providing Patient Days 30,000, Discharges 8,700, Births 1,800, Surgeries 16,200, Outpatient Visits 426,200, Emergency Room Visits 40,800, Urgent Care Visits 42,200, Home Health Visits 41,400, Lab Tests 656,200, Radiology Procedures 108,000, Beds 189, Community Outreach Programs. Holland Hospital holds to the core belief that all members of the community should have access to high quality, affordable health care services. For individuals and families who are at risk, the Community Outreach Committee of the Hospital Board of Directors placed high priority on four community outreach efforts -Holland Community Health Center. The Holland Community Health Center (HCHC) provides primary health care services for people who are under-insured and uninsured. Over 5,600 patients received their primary medical care at the HCHC. The majority of visits focus on women's and children's health care needs, chronic disease management and elder care. -School Nursing Program. School Nurses provide preventive and treatment services to Holland Public, Holland Christian, West Ottawa Public, Fennville Public and Hamilton Community Schools. More than 11,000 students received services last year through 19,643 health room visits. Over 22,000 medication administrations were given last year, the greatest percentage being psychotropic medications. -Faith Community Nurse. The Faith Community Nurse at the Holland Rescue Mission provided approximately 650 one-on-one client engagements last year, offering basic health information, assessment or ongoing education for health issues as well as referrals for medical, dental, mental, and other kinds of care. The nurse brings health care services and spiritual counseling to one of the community's most vulnerable populations -homeless women and children. -Breast Care Fund. It is estimated that 1 in 8 women will develop invasive breast cancer in their lifetime. Early detection provides the best opportunity to treat breast cancer and reduce the risk of recurrence. The Breast Care Fund provides financial support for mammograms and other breast health services for women in Ottawa County who otherwise would not be able to afford basic breast screening and diagnostic services. Community Health and Wellness. The Center for Good Health (CFGH) offers a variety of educational classes and presentations for children, adults and seniors. In FY 2016, the center offered 458 classes and events with 7,640 participants. In addition to classes and educational programs for the general public, the CFGH also works with many area businesses to provide Workplace Wellness programs directly to employees. Funding Access to Health Care Services for Our Community. The Fund Development office at Holland Hospital raises financial support for four important community outreach efforts: the Holland Community Health Center, the School Nursing Program, the Faith Community Nurse and the Breast Care Fund. In fiscal year 2016, the Fund Development office raised \$436,590.74 to support these efforts. Uncompensated Medical Costs. Our commitment to caring for members of our community who are uninsured or under-insured continues to be one of the biggest financial challenges for the Holland Hospital. In FY 2016, Holland Hospital provided un-reimbursed care to our patients at a cost of \$47.5 million, a 6.5 percent increase over the previous year. The expansion of Michigan's Medicaid program in 2014 has helped relieve some of the hospital's burden of caring for patients who have little or no means to pay. According to a recent study by professors at the University of Michigan, the proportion of those patients who lacked insurance dropped by nearly 4 percentage points, and the proportion covered by Medicaid rose more than 6 points just within three months of the program's expansion. The plan has since enrolled hundreds of thousands of low-income Michiganders between the ages of 18 and 64 in Medicaid coverage. Despite having more covered lives, the most recent Ottawa County Community Needs Assessment (2015) shows -1 in 10 adults does not have health care insurance -6 in 10 adults are overweight (35.3%) or obese (23.9%) -11.4% of the general population does not have a primary care physician (33% among under-served populations). These persistent issues set the stage for a patient population with significant, untreated chronic illnesses which will require significant medical attention and cost to treat in the future. 2016 Community Benefit Summary - \$47.5 Million Total Community Benefit.
