Legislative

The Minnesota AFL-CIO advocated for numerous issues in the 2015-2016 Biennial Legislative Session. Some passed and many did not – in large part due to a divided legislature. The successes included, extended unemployment benefits to taconite miners in northeastern Minnesota, passage of state employee contracts and 12 weeks of paid family and medical leave passed the Senate but not the House. Important legislation that did not pass included, comprehensive transportation/transit funding, and a capital investment bonding bill.

Legislative/Political Conference

We hosted our Legislative and Political Conference on November 12-13, 2015. Attendees learned about legislative issues that could arise in the 2016 Legislative Session and skills to use during the 2016 election season.

Political

The Labor 2016 Political Plan was approved at the Minnesota AFL-CIO Executive Board on January 2016 and the General Board on February 16, 2016. The plan is being implemented and considerable effort will be put into educating and mobilizing the members of our affiliated unions to support our endorsed candidates in the 2016 elections.

Organizing

The organizing director and strategic research director work to expand affiliates' capacity to wage strategic organizing campaigns, coordinate support for affiliate organizing, and work on initiatives to grow union employers. Over the past two years, the Organizing Department has supported over 40 affiliates with consultation, direct support, and/or trainings to support internal and external organizing.

State Fair

We coordinated the planning and activities of our affiliates at the Minnesota AFL-CIO Labor Pavilion at the Minnesota State Fair.

Communications

In addition to the ongoing work of the Communications staff – the weekly email *Labor Update*, press releases and interviews, the *Minnesota Works* podcast – we greatly expanded and upgraded our digital communications capabilities to improve our reach and redesigned our website. We also began using live video streaming capabilities for Labor events and actions.
