	The WCP scholarship donations prepare dedicated, talented, and exceptional underprivileged children to lead their communities and our world into the future. WCP partner school, La Paz Community School, integrates local underprivileged youth into the program at a young age in order to help them preserve the unique local traditions and ecology while celebrating the peaceful integration of foreign cultures and ideas into the community. During the 2015-2016 school year there were 40 local students who are all excelling at La Paz as they transform into creative, analytical, and peaceful thinkers who are responsible, bilingual, active stewards of our community and beyond. WCP took a huge step forward this year to ensuring the future sustainability of the Scholarship Program by creating the Friends of La Paz Endowment Fund. WCP capital campaign donations allow partner schools like La Paz to develop the necessary infrastructure and resources to support high quality education for over 300 students from PreK 12th grade. Donations contributed throughout the year to this fund are being dedicated towards the success of phase three which will see the construction of the new Prek - 2nd learning pod of classrooms. The WCP General Fund provides necessary educational materials such as books, art supplies, technology, math manipulatives and uniforms to improve the education of students in our partner schools.
